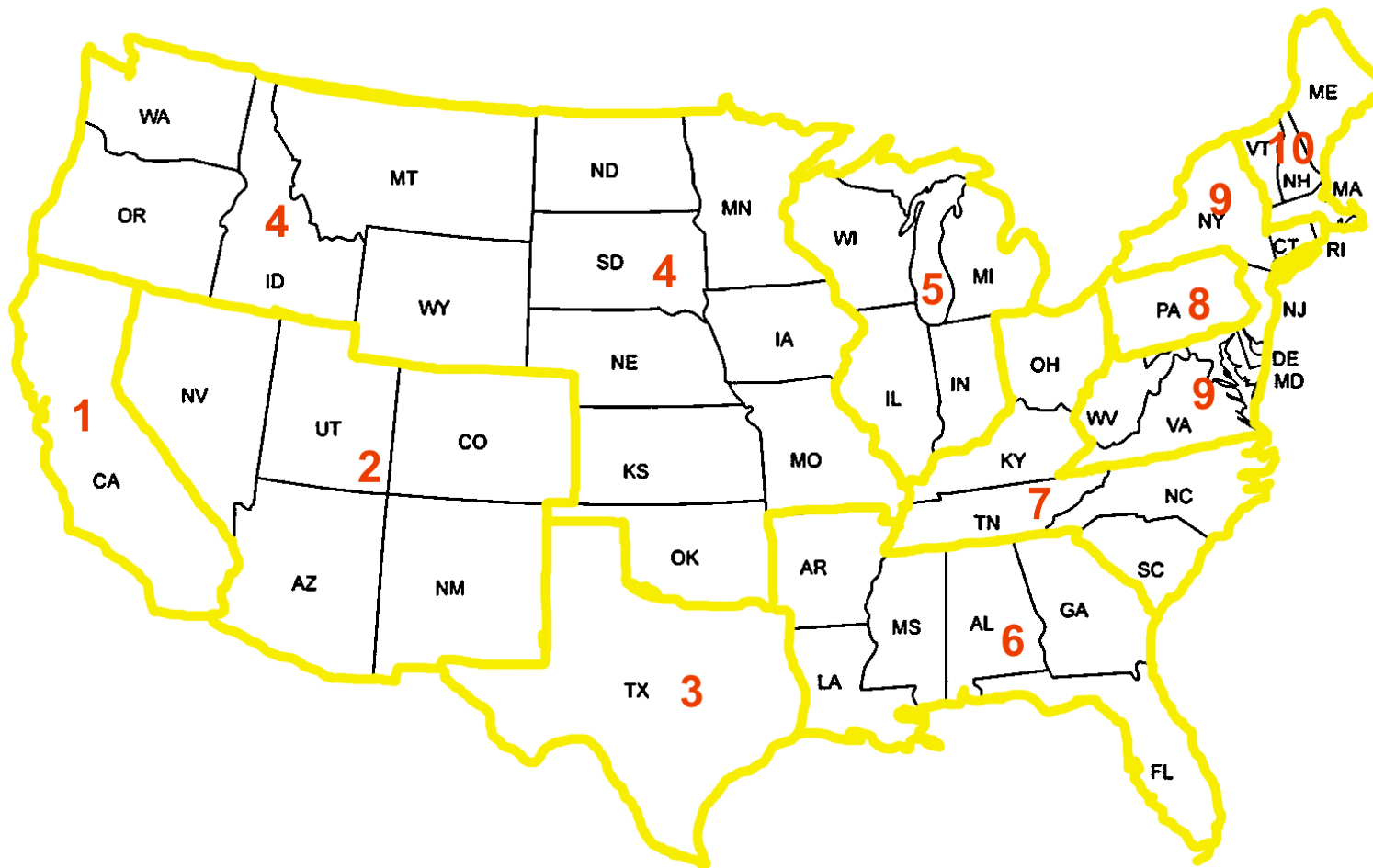

Tournament Courses

TEAM – Paul Stolzenburg

All courses are to be submitted in one email addressed to 1-3 reviewers depending on the courses being submitted.

For example:

- **Titling** courses only – Regional Reviewer
- **Titling** courses and **STP/PSJ** and/or **GP/PGP** – Regional Reviewer & Scott Chamberlain
- **Titling** courses and **TEAM** – Regional Reviewer & Paul Stolzenburg
- **Titling** course, **STP/PSJ** and/or **GP/PGP**, and **TEAM** – Regional Reviewer & Scott Chamberlain & Paul Stolzenburg

Please remember course are due for review:

- Judges under supervision – 6 weeks (42 days) prior to the first day of the assignment.
- Judges off of supervision – 4 weeks (28 days) prior to the first day of the assignment.
