³ When a veterinarian's statement is requested, it should be submitted on their official letterhead, providing their name, license number, address, telephone number and email address, if any, and respond to the following:

- Description of the condition for which the examination has been conducted
- Description of the physical condition of the dog with attention focused on a dog's conditioning and readiness for participation in athletic type activities (e.g., good muscular development and tone, weight, conformation characteristics that may affect physical movement, etc.)
- What tests and procedures were conducted to evaluate the condition
- The determination of likely cause and basis for that determination
